The Jury Service Allowance is limited to a maximum of 10 days at £500 per day minus a deduction of any amount recovered from the relevant court. In order to arrive at the daily amount payable, the IPSE Plus member will be asked to provide details of the length and value of the current engagement from which it will be possible to calculate a daily rate.
